

# 2024 WINTER NATIONALS

(CITRUS COUNTY SPEEDWAY)

## LEGEND CAR AND BANDOLERO CAR

### TIRE RULES

#### The following rules will be in place for the 2024 Legend Car Winter Nationals.

- INEX marked, new Hoosier tires purchased directly through US Legend Cars International are required to be used for this event.
- A minimum of 4, a maximum of 6 for Legend Cars (maximum of 5 for Bandolero Cars) new Hoosier tires per driver must be marked by INEX for this event prior to delivery. These marked tires will be checked at the track prior to the car going on-track. **DO NOT TAMPER WITH ANY MARKINGS ON THE SIDEWALL OF THE TIRES.**
- If you choose to have less than 6 for Legend Cars (5 for Bandolero Cars) tires marked by INEX for this event, you will not be able add more tires to your "inventory" during the week (EIRI).
- Tires will be marked with individual car numbers and are not allowed to be used on other competitors cars.
- Each day, including event practice, you can use your INEX marked tires in any combination on your car (tires can be moved around the car for stagger / wear).
- Your extra INEX marked tires, not on your car, must remain in your pit area & must not be taken into your trailer.
- Your INEX marked tires and INEX legal unmarked tires can be used in all event practices.  
**NOTE:** (Afterhours practice must be done on unmarked tires. Your Winternationals / INEX marked tires must be turned in to impound prior to afterhours practice. If you use your Winternationals / INEX marked tires during the afterhours practice, they will be impounded & not returned).
- Tires that INEX determines have been altered physically or chemically after they have been marked by INEX will be confiscated & that car, driver & crew chief will be disqualified, removed from the event & face possible INEX suspension.

- The INEX marked tires are the mandatory (and only) tires permitted to be used for qualifying and the main events.
- Buffing, cutting, heating, washing, etc. of these tires is not permitted.
- Chemicals are not permitted on the tires.
- If an INEX marked tire is damaged in on-track competition, drivers will use their "spare" INEX marked tires for replacement.
- In the rare occurrence that a car needs more than its 6 for Legend Cars (5 for Bandolero Cars) INEX marked tires (big wreck, more than 2 flats, etc.), That must be approved by John Kelly.
- If a competitor purposefully flattens INEX marked tires for the purpose of getting a new tire, that competitor will be penalized by INEX.
- You are not required to purchase new tires at the track. You will purchase tires directly through Kyle McGowan at US Legend Cars International after you have signed up for this event (sign up for this event will be done directly through Citrus County Speedway). These new tires will be specifically marked with your car number for this event prior to delivery.
- **Tire grinders, tire rotisseries, shrinking / stretching machines or any machines designed to buff, grind, heat, wash or prep. tires are not allowed in the pit area or on Citrus County Speedway property. If found on property, this equipment will be confiscated.**
- Enclosed "tire tents" are not permitted. Enclosed "car / team" tents are permitted (these "car / team" tents must be fully accessible to any INEX official).
- **YOUR INEX MARKED TIRES MUST BE TURNED IN TO IMPOUND WITHIN 30 MINUTES OF THE LAST CHECKERED FLAG ON EACH DAY OF THIS EVENT. IF YOU DO NOT TURN YOUR TIRES INTO IMPOUND, YOU WILL NOT BE ALLOWED TO COMPETE ANY FURTHER DURING THIS EVENT.**

**~ TIRE RULES ARE SUBJECT TO CHANGE BY INEX. ANY AMMENDMENTS WILL BE POSTED OR ANNOUNCED AT THE DRIVERS MEETING.**

**~ ANY QUESTIONS ABOUT THE TIRE RULES WILL BE ANSWERED BY INEX & THAT DECISION IS FINAL.**
